The Montgomeryshire County Council in their capacity as local planning authority have completed the review required by section 61 of the National Parks and Access to the Countryside Act, 1949, and are of the opinion that as respects their area no such action needs to be taken as is mentioned in subsection (1) of the said section.

Representations that action needs to be taken may be made to the Under Secretary, the Welsh Office, Ministry of Housing and Local Government, Cathays Park, Cardiff, not later than 31st day of March 1952.
