LAND DRAINAGE ACT, 1930.

*Yorkshire Ouse River Board.*

Dun Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, proposes to make an Order confirming a scheme submitted to him by the Yorkshire Ouse River Board, under Section 4 (1) (b) of the Act, making provision for the following matters:—

1. The alteration of the boundaries of the Dun Drainage District.
2. The reconstitution of the Drainage Board for the said Drainage District as so altered and extended.
3. The making of alterations in the provisions of certain local Acts.
4. Matters supplemental to or consequential upon the above.

A copy of the draft Order has been deposited, together with a copy of the Scheme, and of the map referred to therein, at the Office of the Clerk of the Dun Drainage Commissioners, 12, Kings Arcade Chambers, Doncaster, and at the Office of the Ministry of Agriculture and Fisheries, Someries House, Regent's Park, London, N.W.1, for public inspection for a period of thirty-five days from the date of this notice and may be inspected during normal office hours.

Notice is hereby given in pursuance of Section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Orders:—

Statutory Instruments 1952 No. 151.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 10, 1952.*

(Made 29th January, 1952.)

1. Contracts, as from 3rd February, 1952, the Foot-and-Mouth Disease Infected Area around Coldred, Dover, Kent, declared by the Foot-and-Mouth Disease (Infected Areas) Special Order No. 4, 1952, to an area comprising the districts situate within approximately 5 miles of Sandwich, Kent.

2. Releases such contracted Infected Area from restrictions on 10th February, 1952.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 11, 1952.*
