Sugar Beet Eelworm.

NOTICE is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Destructive Insects and Pests Act, 1877 to 1927, entitled "The Sugar Beet Eelworm Order, 1952." This Order supersedes the Sugar Beet Eelworm Orders, 1943 and 1950.

A number of places in the vicinity of which the eelworm is known to exist have been declared to be "Infested Areas" and are described in the Schedule to the Order. Restrictions are placed on the growing within an "Infested Area" or on land

known to be infested, of all crops likely to encourage the increase of the eelworm.
