WHEREAS by the Acts of Uniformity which establish the Liturgy, and enact, that no Form or Order of Common Prayers be openly used other than what is prescribed and appointed to be used in and by the said Book, it is notwithstanding provided, that in all those Prayers, Litanies, and Collects which do anyway relate to the King, Queen, or Royal Progeny, the Names be altered and changed from Time to Time, and fitted to the present Occasion, according to Direction of lawful Authority: Her Majesty was pleased this day in Council to declare Her Royal Will and Pleasure, That in all the Prayers, Liturgies, and Collects for the King, instead of the Word "King" the Word "Queen", instead of the Word "George" the Word "Elizabeth", instead of the Words "Sovereign Lord" the Words "Sovereign Lady", and in the Prayers for the Royal Family, instead of the Words "our gracious Queen Elizabeth, Mary the Queen Mother, the Princess Elizabeth, the Duke of Edinburgh" the Words "Elizabeth the Queen Mother, Queen Mary, Philip Duke of Edinburgh, Charles Duke of Cornwall" be inserted: And that in all the Prayers, Liturgies, and Collects, so altered, such change of the Pronouns "He", "Him" and "His" be made, as will be by those Alterations rendered necessary. And Her Maiesty doth strictly charge and com-

And Her Majesty doth strictly charge and com-mand, That no Edition of the Common Prayer be from henceforth printed but with this Amendment; and that in the meantime, till Copies of such Edition may be had, all Parsons, Vicars, and Curates in the Provinces of Canterbury and York do (for the preventing of Mistakes), with the Pen, correct and amend all such Prayers in their Church Books, according to the aforegoing Direction: And correct and amend all such Prayers in their Church Books, according to the aforegoing Direction: And for the better Notice hereof, that this Order be forthwith printed and published, and sent to the several Parishes; and that the Right Reverend the Bishops do take care that Obedience be paid to the same accordingly.
