## FOOD AND DRUGS ACT, 1938.

*The Borough of Nelson (Food) Order, 1952.*

BY an Order taking effect on the 28th day of March 1952 the Minister of Health has

(1) declared that Section 14 of the Food and Drugs Act 1938 shall be in force in the Borough of Nelson. (This Section requires the registration of premises used in connection with the manufacture or sale of ice cream or preserved food &c.);

(2) specified Section 116 of the Lancashire County Council (Rivers Board and General Powers) Act 1938 as a provision which shall be repealed as respects the Borough. (This provision required the registration in County Districts of premises used in connection with the sale of ice cream or preserved food).
