## DISEASES OF ANIMALS ACT, 1950.

Notice is hereby given in pursuance of Section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Orders:—

Statutory Instruments 1952 No. 585.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 33, 1952.*

(Made 19th March, 1952)

1. Contracts, as from 23rd March, 1952, the Foot-and-Mouth Disease Infected Area around Staplehurst, Kent, declared by Special Order No. 25, 1952, to an area comprising the districts situate within approximately 5 miles of Staplehurst.

2. Releases such contracted Infected Area from restrictions on 30th March, 1952.

Statutory Instruments 1952 No. 586.

*The Poultry and Hatching Eggs (Importation) (Amendment) Order, 1952.*

(Made 19th March, 1952.)

This Order, which comes into operation on 27th March, 1952, amends a schedule to the Poultry and Hatching Eggs (Importation) Order of 1947 so as to exclude Canada, Holland and the Union of South Africa from the countries from which live poultry and hatching eggs may be imported.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 34, 1952.*

(Made 20th March, 1952.)

Extends the Foot-and-Mouth Disease Infected Area around Framlingham, Old Newton, Reydon and Shipmeadow, Suffolk, declared by Special Order No. 31, 1952, so as to include those parts of the counties of Essex and East and West Suffolk which lie within approximately 15 miles of Foxhall, Suffolk.

Statutory Instruments 1952 No. 621.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 35, 1952.*

(Made 21st March, 1952.)

Declares an area comprising the districts situate within approximately 15 miles of Sandwich, Kent, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the county of Kent.

Statutory Instruments 1952 No. 638.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 36, 1952.*

(Made 22nd March, 1952.)

Extends the Foot-and-Mouth Disease Infected Area around Sandwich, Kent, declared by Special Order No. 35, 1952, so as to include the Borough of Hythe, Kent.

Statutory Instruments 1952 No. 639.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 37, 1952.*

(Made 22nd March, 1952.)

Extends the Foot-and-Mouth Disease Infected Area around Framlingham, Old Newton, Reydon and Shipmeadow, Suffolk, declared by Special Order No. 31, 1952, and extended by Special Order No. 34, 1952, so as to include those parts of the counties of Cambridge, Norfolk and West Suffolk which lie within approximately 15 miles of Flempton, Bury St. Edmunds.

Statutory Instruments 1952 No. 651.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 38, 1952.*

(Made 24th March, 1952.)

Extends the Foot-and-Mouth Disease Infected Area around Framlingham, Old Newton, Reydon and Shipmeadow, Suffolk, declared by Special Order No. 31, 1952, and extended by Special Orders Nos.

34 and 37, 1952, so as to include those parts of the counties of Cambridge, Isle of Ely and Norfolk which lie approximately 15 miles of Soham, Ely.

Statutory Instruments 1952 No. 652.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 39, 1952.*

(Made 24th March, 1952.)

Declares an area comprising the districts situate within approximately 15 miles of St. Mary Bourne, Andover, Hampshire, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Berks, Southampton and Wilts.
