1. Age

Candidates must be at least 21 and under 28 years of age on the 1st August, 1952.

Provided that the Commissioners may, at their discretion, waive the maximum age limit in favour of a candidate who, although eligible, was prevented from attending the Limited Competition of 1951 for the Executive Classes as a result of having been recalled from the Reserve for a period of service or training with H.M. Forces.

2. Sex.

Both men and women are eligible, but women will not ordinarily be appointed to posts in the Admiralty or to the Immigration Service of the Home Office.

3. Service.

Candidates must either

(a) be serving on the 1st August, 1952, in an established situation in the General Clerical Class or in the Departmental Clerical Classes of the
