NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT 1949.

PART V—ACCESS TO OPEN COUNTRY.

County of the Soke of Peterborough.

IN pursuance of Section 62 (2) of the above Act the Soke of Peterborough County Council (being the Local Planning Authority for the said County) have forwarded a Statement to the Minister of Housing and Local Government intimating their opinion

(a) that there is in the said County no appreciable area of land of the descriptions of "open country" specified in Section 59 (2) of the Act (i.e. an area of land consisting wholly or predominantly of mountain, moor, heath, down, cliff or foreshore), the only land which might conceivably come within any of the said descriptions being the area of land known as Ailsworth Heath (insofar as such land is not used as a Nature Reserve) and

(b) that as respects the said County no action needs to be taken, whether by the making of access agreements or orders or by the acquisition of land, for securing access by the public for open-air recreation.

Notice is hereby given that if any person or organisation wishes to make any representations that action of the nature aforesaid needs to be taken as respects the said County such representations must be made in writing and must be addressed to the Minister of Housing and Local Government, Whitehall, London, S.W.1, so as to reach him not later than the 11th day of August, 1952.

HASTINGS COUNTY BOROUGH COUNCIL.

The County Borough of Hastings (High Beech Farm) Diversion Order. 1952.
