"3. Upon the union taking effect the church of Saint Paul, Bath, shall become the parish church of the united parish. The marriage registers current at the church of Holy Trinity, Walcot (or Bath), shall be dealt with in accordance with section 62 of the Marriage Act, 1949, and the register books (if any) of baptisms and burials and other the records and muniments deposited in the said church shall be transferred to the parish church of Saint Paul, Bath.

"4. After the said union has taken effect the patronage of the united benefice shall be exercised solely by the patrons of Walcot (or Bath), Holy Trinity.

"2. 'The union of the benefice and parish of Bath. Saint Michael, and the remaining part of the benefice and parish of Bath, Saint Paul'.

"1. The said benefice and parish of Bath, Saint Michael and the remaining part of the benefice and parish of Bath, Saint Paul, shall be permanently united together and form one benefice with cure of souls under the style of 'Bath, Saint Michael with Saint Paul' and one parish for ecclesiastical purposes.

"2. Upon the day when any Order of Your Majesty in Council ratifying this Scheme is published in the London Gazette the union shall take effect foorthwith.

"3. Upon the union taking effect the parish church of Saint Michael shall become the parish church of the united parish.

"4. Upon the union taking effect the parsonage house at present belonging to the benefice of Bath, Saint Michael, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, so soon as conveniently may be, be sold and disposed of by us the said Church Commissioners at such time or times and in such manner in all respects as to us shall seem expedient

commissioners at such time or times and in such manner in all respects as to us shall seem expedient, and the net proceeds of such sale shall constitute and form part of the Expenses Fund of the diocese of Bath and Wells established pursuant to the Union of Benefices Measure, 1923.

"5. With the consents (testified by their signatures hereto) of the Very Reverend John Gerhard Tiarks, the Right Reverend Hugh Rowlands Gough, Bishop Suffragan of Barking, the Reverend Russell Berridge White, the Reverend Reginald Samuel Sidney Heath and the Reverend Laurence Phillips Sheath being the patrons of the benefice of Bath, Saint Michael, and with the consents (testified by their signatures hereto) of the Right Reverend Hugh Rowlands Gough, Bishop Suffragan of Barking, the Reverend William George Martin Claris Colbourn, and the Reverend Edward Hayward, being the patrons of the benefice of Bath, Saint Michael, shall without any conveyance

or assurance other than this Scheme be surrendered in favour of the said patrons of Bath, Saint Paul, and the patronage of the united benefice shall there-upon belong wholly to the said patrons of Bath.

and the patronage of the united benefice shall therepupon belong wholly to the said patrons of Bath. Saint Paul.

"6.—(a) Upon the union taking effect the whole of the endowments and property at present belonging to the benefice of Bath, Saint Paul, shall be assigned and annexed to the united benefice of Bath, Saint Michael with Saint Paul.

"(b) With the consents (testified as aforesaid) of the Right Reverend Hugh Rowlands Gough, Bishop Suffragan of Barking, the Reverend William George Martin Claris Colbourn and the Reverend Edward Hayward, as patrons of the benefice of Bath, Saint Paul, a part of the endowments of the benefice of Bath, Saint Paul, namely a capital sum sufficient to produce an annual sum of £83 being part of a larger capital sum held by us the said Church Commissioners on behalf of the benefice of Bath, Saint Paul, and from the united benefice of Bath, Saint Paul, and from the united benefice of Bath, Saint Michael with Saint Paul, and be transferred to, held and accumulated by us, the said Church Commissioners, as a fund for the endowment Church Commissioners, as a fund for the endowment of a proposed new district to be taken wholly or partly out of the parish of Saint Luke, South Lyncombe, provided that, pending the formation of the said new district the interest on the said fund may if the Bishop of the diocese approves be paid to the diocesan board of finance of the diocese of Bath and Wells towards the stipend of a curate serving the area."
