MERCHANDISE MARKS.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 86, 1952.

(Made 22nd May, 1952.)

Declares, as from 24th May, 1952, Foot-and-Mouth Disease Infected Areas around (1) Ashford and Paddlesworth, Kent, and (2) Hellingly, Hailsham, Sussex, which replace and contract the Foot-and-Mouth Disease Infected Areas around (1) Rye Harbour, Rye, Sussex, declared by Special Order No. 65, 1952, (2) Tonge, Sittingbourne, Kent, declared by Special Order No. 69, 1952, and contracted by Special Order No. 80, 1952, and (3) Hellingly, Hailsham, Sussex, declared by Special Order No. 75, 1952, and extended by Special Order No. 76, 1952.

Statutory Instruments 1952 No. 1047.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 87, 1952.

(Made 23rd May, 1952.)

Declares an area comprising the districts situate within approximately 15 miles of Brenchley, Kent, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Kent and East Sussex.

Statutory Instruments 1952 No. 1048.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 88, 1952.

(Made 24th May, 1952.)

1. Extends, as from 26th May, 1952, the Foot-and-Mouth Disease Infected Area around Ashford and Paddlesworth, Kent, declared by Special Order No. 86, 1952, so as to include the Boroughs of Margate and Ramsgate and the parish of Broadstairs and St. Peters, Kent.
