DIVERSION ORDER, 1951.

NOTICE is hereby given that on the 27th day of May 1952 the Minister of Housing and Local Government confirmed with modifications the above Order.

The effect of the order is to divert the public right of way running from Coldharbour, Goring Heath, in a north-westerly direction to Stapnalls Farm, Whitchurch, and passing through the gardens of Stapnalls Farm turning in a southerly direction to Little Chalk Wood to a line running from a point marked "A" on the map annexed to the order in a south-westerly direction to a point marked "C" on the said map.

A certified copy of the order and of the map contained in the order as confirmed by the Minister has been deposited at Easby House, Northfield End, Henley-on-Thames, and will be open for inspection free of charge between the hours of 10 a.m. and 4 p.m.

ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the order he may, within six weeks from the date of publication of this notice make application to the High Court.
