The QUEEN has been graciously pleased to approve the following immediate award in recognition of gallantry displayed in flying operations in Korea:—

Appointed as Companion of the Distinguished
Service Order.

Acting Wing Commander Ronald Thomas SUSANS,
D.F.C. (04391), Royal Australian Air Force,
No. 77 Squadron.

Wing Commander Susans has commanded No. 77 Squadron since December, 1951. During the period of his command, No. 77 Squadron has become one of the finest and most efficient operational units serving with the United Nations Forces, and has maintained a higher monthly total of operational sorties than any other fighter unit serving in the Korean campaign. Recently, on 10th May, 1952, this squadron flew 76 operational sorties in one day. These were fighter sweeps in support of an all out bomber and ground attack operation in the Pyongyang area. This total now stands as the highest yet recorded in one day by any fighter squadron operating in the theatre. Wing Commander Susans has personally led his squadron on 110 operational missions, 100 of which have been on rocket and low level machine-gun attacks against heavily defended enemy targets in North Korea, and, although his aircraft has been frequently hit by ground fire and on one occasion badly damaged, he has always displayed a fine fighting spirit and has pressed home his attacks at a low level with the utmost vigour and determination. Wing Commander Susans is now serving on his fifth operational tour on fighter aircraft outside Australia and has flown a total of 382 operational missions against the enemy in two wars. His leadership, personal example and devotion to duty have been an inspiration to all with whom he has come into contact, and during his command No. 77 Squadron has gained the respect and admiration of the United Nations Forces as a whole.

The Civil Service Commissioners hereby give notice, in pursuance of Clause 13 of the General Regulations made under the Order in Council of 22nd July, 1920, that, with the approval of the Lords Commissioners of the Treasury, they have prescribed as follows:—
