1. In pursuance of the powers conferred upon me by section three of the Public Health Acts Amendment Act, 1907, I do by this Order on an application made to me by each of the Councils of the boroughs, urban districts and rural districts named in the Schedule to this Order declare section eighty-six of the said Act (which relates to dealers in old metal and marine stores) to be in force in each of those boroughs, urban districts and rural districts.

2. In pursuance of the said powers, I direct that each of the said Councils shall within three weeks from the date of this Order cause a copy thereof and of so much of the Schedule thereto as relates to their borough or district to be published in two or more local newspapers circulating in the borough or district.

3. This Order may be cited as the Old Metal Dealers (No. 3) Order, 1952.

## PUBLIC HEALTH ACTS.

The Old Metal Dealers (Stockport) Order, 1952.

Made 5th June, 1952.

1. In pursuance of the powers conferred upon me by section three of the Public Health Acts Amendment Act, 1907 (7 Edw. 7, c. 53), I, by this Order made on the application of the council of the county borough of Stockport, declare section eighty-six of that Act (which relates to dealers in old metal and marine stores) to be in force in the county borough of Stockport.

2. In pursuance of the said powers I further declare section fifty-one of the Stockport Corporation Act, 1905 (5 Edw. 7, clvii), to be no longer in force in the said county borough.

3. In pursuance of the said powers I direct that the said Council shall within three weeks from the date of this Order cause a copy thereof to be published in two or more local newspapers circulating in the said county borough.

4. This Order may be cited as the Old Metal Dealers (Stockport) Order, 1952.

Section 86 of the Public Health Acts, Amendment Act, 1907, provides as follows:—

1. Every person who shall carry on business as a dealer in old metal or as a marine store dealer shall register his name and place of abode and every place

of business, warehouse, store, and place of deposit occupied or used by him for the purpose of such business, in a book to be kept for the purpose at the offices of the local authority.

2. Every person carrying on business as aforesaid shall correctly enter in a book to be kept for that purpose the description and price of all articles purchased or otherwise acquired by him, and the name, address, and occupation of the person from whom the same were purchased or otherwise acquired.

3. Every person who shall carry on such business without having so registered or without keeping such book and making such entries as required by this section shall be liable to a penalty not exceeding five pounds and to a daily penalty not exceeding forty shillings.

4. Any officer of the local authority or other person duly authorised in writing in that behalf by the local authority, and if so required exhibiting his authority, shall have free access at all reasonable times to every such place of business, warehouse, store and place of deposit, to inspect the same and the books by this section required to be kept, and every person who shall prevent, hinder, or obstruct any officer or person so authorised in the execution of his duty under this subsection shall be liable to a penalty not exceeding five pounds.

Section 86—Registration of Dealers in Old Metal.

NOTICE is hereby given that the Secretary of State has, on application made by the Borough Council of Prestwich, made an order declaring section 86 of the Public Health Acts Amendment Act, 1907 (which relates to dealers in old metal and marine stores) to be in force in the said borough.

This section, which is comprised in Part VII of the Act, provides that every old metal or marine store dealer in the borough must register his name,
