- "7. Alteration of boundaries. Upon the union taking effect and with the consents (testified by their signatures hereto) of the Reverend Cornelius Antonius de Jong, the Reverend Herbert James Beck and the Reverend Norman Stuart Pollock, being the incumbents respectively of the benefices of Brentford, Saint Faith; Hanwell, Saint Thomas; and Isleworth, Saint Francis all in the said diocese of London, (1) all those parts of the parishes of Saint Faith, Brentford, and Saint Francis, Isleworth, which are described in Part One of the Schedule hereto shall be cribed in Part One of the Schedule hereto shall be severed from their respective parishes and be annexed to the parish of the united benefice of Brentford Saint Lawrence with Saint Paul, (2) all those parts of the parishes of New Brentford (Saint Lawrence) and Saint Paul, Old Brentford, which are described in Part Two of the schedule hereto shall be severed from their respective parishes and from the parish of the united benefice and be annexed to the parish of Saint Faith, Brentford, and (3) all that part of the parish of New Brentford (Saint Lawrence) which is described in Part Three of the schedule hereto shall be severed from that parish and from the parish be severed from that parish and from the parish of the united benefice and be annexed to the parish of Saint Thomas, Hanwell.

"8. Diversion of endowments. Upon the union taking effect and with the consents (testified as aforesaid) of the said William, Bishop of London, a part of the endowments of the united benefice, namely, an annual sum of £180 12s. Od. being part of a larger annual sum at present payable by us, the said Church Commissioners, to the benefice of Old Brentford, Saint Paul, shall be severed or diverted from the said benefice and from the united benefice and shall be transferred to and held by us, the said Church Commissioners, as part of and for the benefit of our General Fund and in consideration of the said transfer we shall make out of the said General Fund such periodical payments to the diocesan stipends fund of the diocese of London as we from time to time determine to be equitable having regard time to time determine to be equitable having regard to the value of the said endowments.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of June, 1952, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before to 1936, have prepared and now humbly lay before Your Majesty in Council the following Supplementary Scheme (1) for making certain alterations and additions to the provisions of an Order of His late Majesty King George the Fifth in Council (hereinafter referred to as 'the said Order in Council') dated the 21st day of March, 1924, and published in the London Gazette on the 28th day of March in the same year for effecting the union of the benefice of Marlborough, Saint Peter and Saint Paul, and the benefice of Marlborough, Saint Mary the Virgin, both situate in the diocese of Salisbury, and (2) for altering the boundaries of the parish of Preshute in the same diocese.

" SCHEME.
