Canon Alfred Swann being the incumbent of the said united benefice (testified by their signing this Scheme) do humbly recommend and propose to Your Majesty as follows, that is to say,

"1. Name of the united benefice. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the name of the said united benefice shall be altered to 'The United Benefice of Marlborough, Saint Mary the Victim with Saint Peter and Saint Saint Mary the Virgin with Saint Peter and Saint Paul'.

"2. Union of Parishes. Upon the said day the parish of Saint Mary the Virgin, Marlborough, and the parish of Saint Peter and Saint Paul, Marlborough, shall, subject as hereinafter provided, forthwith he parmanently united together and form forthwith be permanently united together and form one parish for ecclesiastical purposes.

3. Parish Church. The parish church of the parish of Saint Mary the Virgin, Marlborough, shall be the parish church of the united parish.

"4. Registers. The marriage registers at the church of Saint Peter and Saint Paul, Marlborough, shall be dealt with by the incumbent of the said united benefice in accordance with the provisions of section 62 of the Marriage Act, 1949.

"5. Alteration of boundaries. With the consent (testified by his signature hereto) of the Reverend Peter Dudfield May, being the incumbent of the benefice of Preshute, all that part of the parish of Preshute which is described in the Schedule hereto and delineated on the map annexed to this Scheme shall, upon the union taking effect, be severed from that parish and be annexed to the united parish of Saint Mary the Virgin with Saint Peter and Saint Paul, Marlborough, and the whole of the extraorportial place known as North Savernake which parochial place known as North Savernake, which is also delineated on the said map and coloured green, shall be annexed to the said parish of Preshute.

"SCHEDULE.

"The territory to be annexed to the united parish of Saint Mary the Virgin with Saint Peter and Saint Paul, Marlborough.

"All that part of the parish of Preshute (coloured "All that part of the parish of Preshute (coloured pink on the map annexed hereto) which lies to the northeast of an imaginary line commencing at a point on the boundary which divides the united parish of Saint Mary the Virgin with Saint Peter and Saint Paul, Marlborough, from the parish of Preshute in the middle of Pewsey Road and continuing thence southeastwards along the middle of Pewsey Road to a point opposite the southwestern end of George Lane and continuing thence northeastwards to and along the middle of George Lane to a point opposite the middle of the western end of the track or footpath which runs between George Lane and Isbury Lane and continuing thence eastof the track or footpath which runs between George Lane and Isbury Lane and continuing thence eastwards to and along the middle of the last mentioned track or footpath for a distance of 13½ chains to a point opposite its eastern end in the middle of Isbury Lane and continuing thence generally southeastwards along the middle of Isbury Lane for a distance of 6 chains to its end and continuing thence southeastwards in a straight line across the road known as Upper Church Fields to the middle of the northwestern end of the track or footpath leading to the Marlborough Corporation Pumping Station and continuing thence generally southeastwards along the middle of the last mentioned track or footpath across the Marlborough branch line of British Railways (Western Region) for a distance of 15 chains to a point opposite to the middle of the approach to the said Pumping Station and continuing thence northeastwards in a straight line to the boundary which divides the parish of Preshute from the parish of Savernake."

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

in the manner hereinafter mentioned:

"Now, therefore, we, the said Church Commis-"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Luke, Barrow-in-Furness, and Newbarns and Hawcoat shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"The territory to be annexed to the parish of Newbarns and Hawcoat:—
