Westmoor Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, proposes to make an Order confirming, with certain modifications, a scheme submitted to him by the River Great Ouse Catchment Board, now superseded by the Great Ouse River Board, under Section 4 (1) (b) of the Land Drainage Act, 1930, making provision for the following matters:—

(1) The constitution of the Westmoor Internal Drainage District and of the Drainage Board thereof.

(2) The abolition of the Chatteris Second Drainage District (now known as the Westmoor Drainage District) and of the Commissioners thereof.

(3) The making of alterations in certain Local Acts.

(4) Matters supplemental thereto or consequential thereon.
