WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 9th day of October, 1952, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Shirley and Addington in the diocese of Canterbury.

## " Ѕснеме.

"Whereas, we, the Church Commissioners are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map annexed hereto would be best served by constituting it a new parish and that a suitable endowment there-

"And whereas we have not approved any conse-crated church within the area described in the said Schedule as suitable to be the parish church of the

new parish:
"Now, therefore, with the consent of the Right Honourable and Most Reverend Geoffrey Francis, Archbishop of Canterbury (in testimony whereof he has set his hand and affixed his archiepiscopal seal to this Scheme), we, the said Church Commissioners do humbly recommend and propose as follows, that is to say:

" Constitution:

"(1) As from the licence thereto of a Minister the area defined in the said Schedule and delineated on the said map shall be a separate district for spiritual purposes.

"(2) As from the date of consecration of a church within the area defined in the said Schedule

approved by us as suitable to be a parish church,
