" SCHEME.

"1. Union of Benefices. The benefice of Corse and the benefice of Staunton shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Corse and Staunton', but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Edward George Tilt if he is then incumbent of the said benefices of Corse and Staunton shall with his con-sent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Staunton shall be the house of residence of the incumbent of the united benefice.

" SCHEME.

"1. Union of Benefices. The benefice of Raven-stonedale and the benefice of Saint Aidan, New-biggin, shall be permanently united together and form one benefice with the cure of souls under the style of 'The United Benfice of Ravenstonedale with Newbiggin-on-Lune', but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. "(a) If upon the day when any Order of Your Majesty in Council affirming this Scheme is pub-lished in the London Gazette the benefice of Saint Aidan, Newbiggin, shall be vacant, the union shall forthwith take effect.

"(b) If upon that day the said benefice of Saint Aidan, Newbiggin, shall be full the union shall take effect immediately upon the next vaca-tion thereof and the incumbent (if any) at the relevant date of the benefice of Ravenstonedale shall be the first incumbent of the united benefice.
