The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under section 9 (4) of the Finance Act, 1952, entitled the Purchase Tax (No. 8) Order, 1952.

This Order brings furniture within the scope of the "D" scheme established by section nine of the Finance Act, 1952. It sets out in the Schedule the prescribed list of furniture eligible for "D relief". The figures appearing in the last column of the Schedule represent the amounts which are to be deducted from the Wholesale value for purchase tax purposes of the goods to which they apply. Tax is accordingly chargeable at the appropriate rate on the value (if any) remaining after the deduction.

The Order automatically brings into operation that part of section eight of the Finance Act, 1952, which abolishes the exemption from purchase tax of utility furniture and component parts thereof.
