The Old Metal Dealers (No. 8) Order, 1952.

Made 2nd December, 1952.

The undermentioned Order has been made by the Secretary of State and affects the Rural District Councils in the North Riding of Yorkshire as set out in the Schedule below:—

1. In pursuance of the powers conferred upon me by section three of the Public Health Acts Amendment Act, 1907(a), I do by this Order on an application made to me by the council of the borough and by each of the councils of the urban districts and rural districts named in the Schedule to this Order, declare section eighty-six of the said Act (which relates to dealers in old metal and marine stores) to be in force in that borough and in each of those urban districts and rural districts.

2. In pursuance of the said powers, I direct that each of the said councils shall within three weeks from the date of this Order cause a copy thereof and of so much of the Schedule thereto as relates to their borough or district to be published in two or more local newspapers circulating in the borough or district.

3. This Order may be cited as the Old Metal Dealers (No. 8) Order, 1952.

NOTICE is hereby given that the Cwmbran Development Corporation in pursuance of their powers under section 4 of the New Towns Act, 1946 on the 2nd day of January, 1953, made an Order which has been submitted for confirmation by the Minister of Housing and Local Government authorising them to purchase compulsorily for the purposes of the New Town of Cwmbran the lands described in the Schedule hereto.

Any objection to the Order must be made in writing, stating the grounds of the objection and addressed to the Minister of Housing and Local Government, Whitehall, London, S.W.1, before the 2nd day of February, 1953.

The Minister is not, in all cases, required to arrange for objections to be heard by a person appointed by him for that purpose. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made as the objector may have no further opportunity to make such a statement.

Any owner or occupier of any land to which the Order relates may send to the Cwmbran Development Corporation at the address below, a request in writing to serve him with a notice that the Order has been confirmed, and naming a place where a copy of the Order and of the map and of any descriptive matter annexed thereto, may be seen. Such request should contain a statement of the name, postal address and the interest in the land of the owner or occupier and particulars sufficient to enable the extent and boundaries of the land to be identified.

RURAL DISTRICT COUNCIL OF PENYBONT.

THE COAST PROTECTION ACT, 1949.
