LONDON PASSENGER TRANSPORT ACT, 1933.

DISEASES OF ANIMALS ACT, 1950.

Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Order:—

Statutory Instruments 1953 No. 13.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 1, 1953.

(Made 7th January, 1953.)

Declares an area comprising the districts situate within approximately 15 miles of Crawcrook, Ryton, Co. Durham, to be an Infected Area for the purpose

of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Durham and Northumberland.

PUBLIC LOCAL INQUIRY.

Foreland Point.

The Minister of Housing and Local Government has instructed H. G. Warren, Esq., O.B.E., A.R.I.B.A., M.T.P.I., Inspector, to hold a Public Local Inquiry for the purpose of hearing representations as to the effect on the public interest of the proposal of the Air Ministry to use the sea area shown on the map of which copies have been deposited for public inspection at the offices of the Devon County Council in Exeter, the Somerset County Council in Taunton, the Ilfracombe Urban District Council in Ilfracombe, the Lynton Urban District Council in Lynton, the Barnstaple Rural District Council in Barnstaple, and the Williton Rural District Council in Williton. A Statement of the use to which the Air Ministry propose to put the area, and a copy of Command Paper 7278 ("Needs of the Armed Forces for Training and Other Purposes," Part IX of which deals with the procedure for examining such proposals) have also been deposited for public inspection at the offices of the above-mentioned local authorities. Mr. Warren will accordingly attend at the Council Chamber, the Castle, Barnstaple, at 11 a.m. on Wednesday, the 4th February, 1953.

Any person desirous of making such representations is requested to notify the Minister of Housing and Local Government, Whitehall, London, S.W.1, as soon as possible, and in any case not later than the 26th January, of his wish to do so, and of the general nature of the representations he desires to make.
