6. Health and Character. Successful candidates must satisfy the Commis-sioners as to their health and character.

7. Competition.

(i) The Commissioners may at their discretion summon candidates to a preliminary informal interview.

view. (ii) Likely candidates will be chosen, on the basis of the information available, to appear before a Selection Board appointed by the Commissioners. The Selection Board, in making their recommenda-tions to the Commissioners, and the Commissioners in making their final decision, will give weight to the candidate's capacity for original research or develop-ment work; and they will as a rule expect this capacity to be demonstrated in a candidate's record. The decision of the Commissioners will be final.
