Notice is hereby given that the Minister of Agriculture and Fisheries has prepared a draft Order under section 11 of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, transferring to the River Board of the North West Wales River Board Area the powers, duties, liabilities, obligations and property of the Malltraeth and Corsddaugau Commissioners.

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1937 AND 1948

The Minister of Food gives notice in pursuance of the above-named Regulations, that he hereby recognises the Official Certificate of which particulars are given in the Schedule hereto, as showing (a) that the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Minister; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat product.

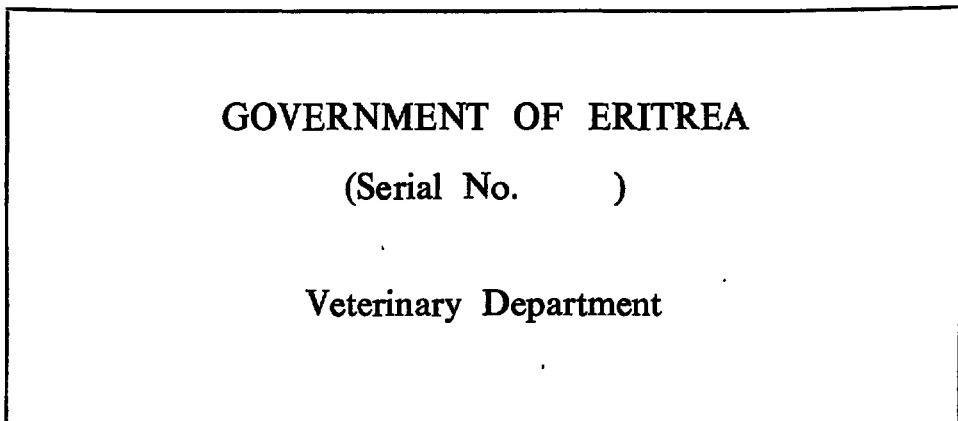
The Certificate being in the form of a label, recognition will apply only if the label is securely affixed to the package containing the meat product.

The Certificate hereby recognised is in substitution for the Certificate reproduced in the Schedule to the Notice published in the London Gazette of the 19th May, 1950, which is hereby revoked.
