WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 30th day of January, 1953, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1952, and the Pastoral Reorganisation Measure, 1949, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Honourable and Most Reverend Cyril, Archbishop of York (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Healaugh with Wighill and the benefice of Bilbrough, both situate in the diocese of York.

" SCHEME.

"1. *Union of Benefices.* The benefice of Healaugh with Wighill and the benefice of Bilbrough shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Healaugh with Wighill and Bilbrough', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend John Hardy Stokes if he is then incumbent of the said benefice of Healaugh with Wighill shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage House.* Upon the union taking effect the parsonage house at present belonging to the benefice of Healaugh with Wighill shall be the house of residence of the incumbent of the united benefice."

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of January, 1953, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint James, Clitheroe, and Saint Paul, Low Moor, Clitheroe, both in the diocese of Blackburn.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Wilfred, Bishop of Blackburn, consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint James, Clitheroe, and Saint Paul, Low Moor, Clitheroe, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

" THE SCHEDULE.

"The territory (coloured pink on the map annexed hereto) to be transferred to the parish of Saint Paul, Low Moor, Clitheroe.

"All that part of the parish of Saint James, Clitheroe which is bounded upon the south and upon the west by the parish of Mitton upon the north partly by the parish of Mitton and partly by the parish of Saint Paul, Low Moor, Clitheroe, and upon the remaining side by an imaginary line commencing at a point opposite to the middle of the northeastern end of Henthorn Road on the boundary which divides the parish of Saint Paul, Low Moor, Clitheroe, from the parish of Saint James, Clitheroe, and extending thence southwestwards to and along the middle of Henthorn Road to its end and continuing thence in the same direction in a straight line to the middle of Pendleton Brook and continuing thence southwestwards along the middle of the said Brook to the River Ribble and continuing thence in the same direction in a straight line to the boundary which divides the parish of Saint James, Clitheroe, from the parish of Mitton."

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1952, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parish of Stratford-sub-Castle in the diocese of Salisbury.

"Whereas it has been represented to us and appears to us to be desirable that the extra-parochial place known as Old Sarum should be annexed to and form part of the said parish of Stratford-sub-Castle:

"Now, therefore, we, the said Church Commissioners, with the consents of the Right Reverend William, Bishop of Salisbury, (in witness whereof he has signed this Scheme), of the Pastoral Committee of the diocese of Salisbury appointed pursuant to the said Pastoral Reorganisation Measure, 1949, (signified by a Resolution of the said Pastoral Committee dated the 21st day of October, 1952), and of the Reverend Albert Horner Lupton, incumbent of the benefice of Stratford-sub-Castle (in witness whereof he has signed this Scheme), humbly recommend and propose that upon the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the whole of the said extra-parochial place known as Old Sarum (which is delineated and coloured pink on the map annexed hereto) shall be annexed to and form part of the said parish of Stratford-sub-Castle."
