*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 12, 1953.*

1. Declares Foot-and-Mouth Disease Infected Areas around (1) Llanvair Kilgeddin, Abergavenny, Monmouthshire, and (2) Caerau, Maesteg, Glamorgan, which replace and extend the Foot-and-Mouth Disease Infected Area around Newport, Monmouthshire, declared by Special Order No. 6, 1953, and extended by Special Orders Nos. 8 and 9, 1953.

2. Modifies the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 so as to permit, under specified conditions, the movement of pigs from any premises (other than premises situated within two miles of any Infected Place) within the Infected Area around Caerau, Maesteg, Glamorgan, to a slaughterhouse or bacon factory in the County Borough of Newport.
