BOROUGH OF MOSSLEY (FOOD) ORDER, 1953.

NOTICE is hereby given that the Minister of Health has made the above Order, operative from the 11th May, 1953, declaring Section 14 of the Food and Drugs Act, 1938, to be in force in the Borough of Mossley. The Section provides for the registration by the Town Council of premises used for the sale or manufacture for the purposes of sale of ice cream or the storage of ice cream intended for sale or the premaration or manufacture of sausages or
