REGULATIONS FOR THE RECRUITMENT OF ESTATE SURVEYORS AND LANDS OFFICERS (BASIC GRADES). 1. Age

Candidates must be at least 25 and under 35 years of age on 1st June, 1953. But (1) a candidate who has served or is serving on

(i) Both men and women may compete under these
Regulations, except that women will not be eligible

(ii) Married women who have formerly been

Provided that a candidate will not be eligible for an appointment under the Air Ministry unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions, of parents also born within the United Kingdom or in one of the self-governing Dominions, Except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions pre-scribed by the preceding paragraphs, he or she may be admitted to appointment or competition by special permission of the Secretary of State for Air.
