"(b) All that part of the parish of Coulsdon, coloured brown on the map, which is bounded on the east by the parish of All Saints, Kenley, on the northeast by the parish of Saint James, Riddlesdown, and on the remaining sides by an imaginary down, and on the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of Saint James, Riddlesdown, from the parish of Coulsdon, being the middle of the Caterham Branch Line of British Railways (Southern Region), opposite the northeastern end of the wall or fence which divides close number 122 (on the map hereto annexed) from close number 120b and continuing thence southwestwards number 120<sup>b</sup> and continuing thence southwestwards to and along the last mentioned wall or fence, along the wall or fence which divides closes numbered 122 and 121 from close number 120 and along the wall or fence which divides close number 72 from closes numbered 120 and 120<sup>a</sup> to a point opposite the northwestern end of the wall or fence which divides close number 120<sup>a</sup> from close number 119 and continuing thence southeastwards along the last mentioned wall or fence to its southeastern end and in a straight line in continuation thereof to a point in the middle of Foxley Road and continuing thence eastwards then southeastwards along the middle of Foxley Road number 120b and continuing thence southwestwards southeastwards along the middle of Foxley Road to the boundary which divides the parish of All Saints, Kenley, from the parish of Coulsdon."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and sub-mission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette nursuant to the said Measure in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-with registered by the Registrar of the said diocese of Southwark.

"We, the Church Commissioners, acting in pur-suance of the Union of Benefices Measures, 1923 to 1952, have prepared and now humbly lay before Your Majesty in Council the following Scheme for authorising the taking down and sale of the site and materials of the church of the Holy Trinity, Hartle-pool, in the parish of the Holy Trinity, Hartlepool, in the diocese of Durham. the diocese of Durham.

## " SCHEME

"Whereas we, the Church Commissioners, by an Instrument under our Common Seal dated the 28th day of March, 1952, pursuant to the New Parishes Measure, 1943, substituted the church of Saint Barnabas for the said church of the Holy Trinity, Hartlepool, as the parish church of the said parish:

"And whereas the said church of the Holy Trinity, Hartlepool, has ceased to be used for purposes of Divine Service:

"Now therefore we, the said Church Commis-sioners, with the consent of the Right Reverend Michael, Bishop of Durham (testified by his signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:

"1. That so soon as conveniently may be after the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the Church of the Holy Trinity, Hartlepool, shall be taken down and the materials and site there of, together with any ground annexed thereto and mercessary for the use and enjoyment thereof, shall be sold and disposed of by us, the said Church Com-missioners, at such time or times, and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Measures.

"2. That the net proceeds to arise from such sale or sales, after payment of the expenses attendant thereon and upon the taking down of the church, and thereon and upon the taking down of the church, and all other expenses incidental to these matters, shall be appropriated and held by us, the said Church Commissioners as a fund to be applied for and to-wards the cost of providing and erecting a permanent church, to be approved by us, within the said parish of the Holy Trinity, Hartlepool.

"3. That the furniture and fittings of the said church of the Holy Trinity, Hartlepool, or such of them as the Bishop shall select, shall be removed to some other church or chapel or churches or chapels within the said diocese of Durham as the Bishop may direct or shall (with the exception of the font, communion table and plate used for the pur-pose of the Holy Communion) be sold and in such case the proceeds shall be added to the fund arising from the sale of the site and materials of the said church of the Holy Trinity Hartlepool as forcesid" church of the Holy Trinity, Hartlepool, as aforesaid."

say: "We, the Church Commissioners, acting in pur-suance of the Pastoral Reorganisation Measure, 1949, the Union of Benefices Measures, 1923 to 1936, and the Ecclesiastical Commissioners (Powers) Measure, 1938, and with the consent of the Right Reverend George, Bishop of Ripon (in witness whereof he has signed this Scheme), have prepared and now humbly lay before Your Majesty in Council the following Scheme (1) for effecting the union of the benefice of Holy Trinity, Armley Hall, and the benefice of Saint Mary of Bethany, Tong Road, New Wortley, both situate in the diocese of Ripon; and (2) for altering the boundaries of the parish of New Wortley in the same diocese.

## " SCHEME.

"1. Union of Benefices and Parishes. The said benefice of Holy Trinity, Armley Hall, and the said benefice of Saint Mary of Bethany, Tong Road, New Wortley, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Mary, New Wortley, with Holy Trinity, Armley Hall', and the parishes of the said benefices shall also be united into one parish for eccleastical nurnoses for ecclesiastical purposes.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect.

"3. Parish Church. The parish church of the parish of Saint Mary of Bethany, Tong Road, New Wortley, shall be the parish church of the united "3. Parish Church. parish.

"4. Registers. The marriage registers in duplicate current at the church of Holy Trinity, Armley Hall, shall be dealt with in accordance with Section 62 of the Marriage Act, 1949, and the register books of baptism and burials and other the records and muniments deposited in the said church shall be transferred to the parish church of Saint Mary, New Wortley, with Holy Trinity, Armley Hall.
