## NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949.

## LONGBENTON URBAN DISTRICT COUNCIL.

*Longbenton Urban District Council High Weetslade Diversion Order, 1953.*

NOTICE is hereby given that on the 10th day of July, 1953, the Minister of Housing and Local Government confirmed, with modifications, the above Order.

The effect of the Order is to divert a section of the public right of way running from Weetslade Road, Dudley, to the Great North Road, Wideopen (being a section approximately 220 yards in length, starting at a point 600 yards along the path from Weetslade Road) from its present line to a line 40 yards further south.

A certified copy of the Order and of the map contained in the Order has been deposited at the Council Offices, Forest Hall, and will be open for inspection, free of charge, during usual business hours.

The Order becomes operative as from the 21st day of July, 1953, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
