DOCKYARD PORT OF PORTLAND.

ESTABLISHMENT OF CALIBRATION RANGE.

Calibration Range has been established in Newtons Cove between the Nothe and the Northern Arm of Portland Breakwater. When in use a ship will be secured fore and aft to two buoys situated in the following positions:—

- (a) 50° 36′ 07·8″N. 2° 26′ 05″W.
- (b) 50° 36′ 08·4"N. 2° 26′ 12"W.

2. A spherical buoy, coloured green and white horizontal stripes, has been established in position:—
50° 36′ 09·2″N; 2° 26′ 25·7″W.
This marks the inshore extremity of the range.

This marks the inshore extremity of the range. When calibration takes place in this direction the buoy will carry a red flag.

3. A dan buoy, coloured green and white horizontal stripes, carrying a red flag, will be moored in position 50° 36′ 8.4″N; 2° 25′ 08.2″W. as necessary before calibration to seaward takes place.

4. Firing may take place either to the Westward between the ship and the spherical buoy, or to the Eastward between the ship and the dan buoy. When firing is about to take place a large red flag will be flown in the calibrating ship. The firing will always be in the direction in which the calibration ship is headed. headed.

5. Passage between the ship and the buoy carrying the red flag is prohibited whenever the red flag is hoisted in the calibrating ship.

6. Traffic may proceed round the stern of the firing ship at all times.

7. Patrol boats flying red flags will be in the neighbourhood when calibration is about to take place.

All vessels are to obey their instructions.

8. ANCHORAGE: Vessels anchoring within 2 cables of the Calibration Range are warned that

they may be ordered to shift berth at short notice

if they are foul of the range.

9. FISHING: There are no restrictions to fishing other than those laid down in the above paragraphs and those in force in the Port Regulations.
