Chertsey Road—from 59 ft. west of Duke Street to 50 yds. north-east of Church Street, Chobham Road—from Church Path southwards

for 115 feet,

Church Street-between Church Path and Chobham Road,

Goldsworth Road-from the south-east side of Church Street eastwards for 185 feet, Commercial Road—from High Street north-east-

wards for 350 feet, Walton Road—from Chertsey Road to the west side of Stanley Road, Bath Road—from Commercial Road to Church

Street

Maybury Road—on the north-west side from Chertsey Road to Duke Street, and

(ii) to prohibit waiting between 9 a.m. and 8 p.m. on Goldsworth Road, between Vale Farm Road and Church Street.

(a) on the south side on those days of the month bearing even numbers

(b) on the north side on those days of the month bearing odd numbers,

for a longer period than 15 minutes in any hour. Exemption will be provided to permit vehicles to wait for so long as may be necessary to pick up or set down passengers, load or unload goods, or in connection with any building operation or demo-lition or for the carrying out of essential services.
