#### SCHEDULE.

In the county of Bucks.

1. Denham Lane, Chalfont St. Peter, from its junction with Rickmansworth Lane southwards for 337 yards.

2. Chesham Lane, Chalfont St. Peter, between a point 172 yards south-east of its junction with Monument Lane and a point 58 yards north-west of that junction.

3. Rickmansworth Lane, Chalfont St. Peter, between a point 199 yards south of its junction with Monument Lane and a point 191 yards north-east of that junction.

4. Chalfont Lane, Chorleywood, between its junction with Blackett's Wood Drive and its junction with Shire Lane.

##### ROAD RESTRICTION IN STEPNEY.

The Minister of Transport proposes, in exercise of the powers conferred upon him by the London Traffic Act, 1924, section 10, as amended by the London Passenger Transport Act, 1933, section 63, to make Regulations to prohibit the use of the swing bridge over Regents Canal, Narrow Street, Stepney, by all vehicles except pedal cycles, invalid carriages, perambulators and handcars.
