**COUNTY OF THE WEST RIDING OF YORKSHIRE.****ROAD TRAFFIC ACT, 1930. SECTION 46 (1).****ROAD AND RAIL TRAFFIC ACT, 1933. SECTION 29 (4).***Ilkley Urban District and Skipton and Wharfedale Rural Districts.*

NOTICE is hereby given that on the 31st day of August, 1953, the Minister of Transport confirmed the County Council of the West Riding of Yorkshire (Roads Restriction) (No. 2) Order, 1953.

The effect of the Order (which may be inspected at the office of the undersigned) is to prohibit the driving of any heavy locomotive, light locomotive, motor tractor, or heavy motor car, or any motor car with seats for more than 15 persons exclusive of the driver on the Beamsley and Otley County Road (C.119) from the junction of Common Holme Lane with Langbar Road, north-west of Ilkley Bridge, in the Ilkley Urban District, to the junction with the Skipton and Harrogate County Road, A.59, immediately east of Bolton Bridge, in the Skipton Rural District.

**DORSET COUNTY COUNCIL.****TOWN AND COUNTRY PLANNING ACT, 1947.****TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1950.**

NOTICE is hereby given that a Direction made by the County Council of the Administrative County of Dorset being the local planning authority, under Article 4 of the above Development Order and relating to an area of land in field Ordnance Survey No. 243 (Dorset Sheet XLV.8 Second Edition 1902), at West Bexington in the Parish of Puncknowle,

Dorset, on the north side of the Swyre-West Bexington road and having a frontage thereto of approximately 200 feet and a depth of approximately 450 feet, was approved by the Minister of Housing and Local Government on the 24th August, 1953.

The effect of the Direction is that, notwithstanding the provisions of Article 3 of the above Development Order, development of the said land of the description set out in the Schedule hereto may not be carried out unless planning permission therefor is granted on an application made in that behalf under the above Development Order.

The statutory permission to carry out building or engineering operations for the purposes of agriculture is cancelled by the Direction so far as regards the land covered by the Direction.

The Direction comes into force on the date on which notice thereof is first published, viz., the 11th September, 1953.

A copy of the Direction and of the map defining the area to which it relates may be seen at the County Hall, Dorchester, and at the West Area Planning Office, 17B, South Street, Bridport, on weekdays (except Saturdays) between the hours of 9 a.m. and 1 p.m. and between the hours of 2 p.m. and 5.15 p.m. and on Saturdays between the hours of 9 a.m. and 12 noon.

The carrying out of building or engineering operations for the purposes of agriculture being development comprised within Class VI (1) referred to in the First Schedule to the said Order and not being development comprised within any other Class.

**LOCAL GOVERNMENT.****Public Health Acts.***The Hove (Miscellaneous Provisions) Order, 1953.*

Made 27th August, 1953.

1. In pursuance of the powers conferred upon me by section three of the Public Health Acts Amendment Act, 1907 (7 Edw. 7. c. 53), I, by this Order made on the application of the Council of the borough of Hove, declare the following sections of the said Act, that is to say, eighty-one (which extends the definition of public place and street for certain purposes) eighty-three (which confers power to make byelaws for the prevention of danger, obstruction or annoyance to persons using esplanades or promenades) and eighty-six (which relates to dealers in old metal and marine stores), to be in force in the borough of Hove.

2. In pursuance of the said powers I direct that the said Council shall within three weeks from the date of this Order cause a copy thereof to be published in two or more local newspapers circulating in the said borough.

3. This Order may be cited as the Hove (Miscellaneous Provisions) Order, 1953.
