Swine Fever (Infected Areas) (Revocation) Order, 1953. (Made 16th November, 1953.)

This Order, which came into operation on 20th November, 1953, revokes the Swine Fever (Infected Areas) Order, 1953, which prescribed that in certain specified areas no sale or gathering of swine should be held in any market, fairground or saleyard unless the holding thereof was authorised by the Local Authority. Only fat swine for immediate slaughter could be included in such sales. The movement of swine into, out of and within the areas was also regulated. regulated.

The Swine Fever (Infected Areas) (Amendment) Order had already limited the restrictions to the area mentioned in Part III of the First Schedule to the

original Order.
