" SCHEME.

"1. Union of Benefices. The benefice of Maidwell and the benefice of Draughton shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Maidwell with Draughton', but the parishes of the said benefices shall continue in all

parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Norman Reginald Campbell if he is then incumbent of both of the said benefices of Maidwell and Draughton shall with his consent (testified by his signature hereto), he the first incumbent of the united signature hereto), be the first incumbent of the united benefice and his admission thereto shall be without any form or fee of or for presentation or nomination and he shall not be required to pay any fees in respect of his collation, institution, licence, or induction to the united benefice beyond such fees as he would have been liable to pay if his admission to the united benefice had been an admission solely to that one of the said two benefices for the holding of which in plurality with the other a Dispensation was heretofore granted him.
