THE OLD METAL DEALERS (DAGENHAM) ORDER, 1954.

Made - - - 15th January, 1954.

1. In pursuance of the powers conferred upon me by section three of the Public Health Acts Amendment Act, 1907(a), I, by this Order made on the application of the council of the borough of Dagenham declare section eighty-six of that Act (which relates to dealers in old metal and marine stores) to be in force in the borough of Dagenham.

2. In pursuance of the said powers I direct that the said Council shall within three weeks from the date of this Order cause a copy thereof to be published in two or more local newspapers circulating in the said Borough.

3. This Order may be cited as the Old Metal Dealers (Dagenham) Order, 1954.

Street Trading.
