*Croston Internal Drainage District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, confirming, with certain modifications, a Scheme submitted to him by the Lancashire River Board under Section 4 (1) (b) of the Land Drainage Act, 1930, making provision for the following matters:—

(1) The alteration of the boundaries of the Croston Internal Drainage District.

(2) Certain matters supplemental thereto or consequential thereon.

The proposed boundary alterations will affect lands in the Parishes of Croston and Mawdesley.

The Order will become final and have effect as an Act of Parliament unless within thirty-five days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall be subject to special parliamentary procedure.

#### DISEASES OF ANIMALS ACT, 1950.

NOTICE is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Order:—

Statutory Instruments 1954 No. 164.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 5, 1954. (Made 13th February, 1954.)*

1. Declares an area comprising the districts situate within approximately 15 miles of Bletchingley, Redhill, Surrey, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Kent, Surrey, East Sussex and West Sussex.

2. Permits pigs to be sent to a slaughterhouse or bacon-factory in the Infected Area with a licence issued by an Inspector of the Local Authority for the district from which the pigs are moved. Licences issued under this Order do not require countersignature and may be granted only on production of a Ministry of Food delivery advice note.
