

*Ministry of Agriculture and Fisheries.***DISEASES OF ANIMALS ACT, 1950.**

Notice is hereby given in pursuance of Section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Orders:—

Statutory Instruments 1954 No. 190.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 7, 1954. (Made 21st February, 1954.)

1. Declares an area comprising the districts situate within approximately 15 miles of Caddington, Luton, Bedfordshire, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Bedford, Buckingham and Hertford.

2. Permits pigs to be sent to a slaughterhouse or bacon-factory in the Infected Area with a licence issued by an Inspector of the Local Authority for the district from which the pigs are moved. Licences issued under this Order do not require counter-signature and may be granted only on production of a Ministry of Food delivery advice note.

Statutory Instruments 1954 No. 194.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 8, 1954. (Made 22nd February, 1954.)

Extends the Foot-and-Mouth Disease Infected Area around Caddington, Luton, Bedfordshire, declared by Special Order No. 7, 1954, so as to include the parishes of Great Missenden, Little Missenden and Amersham, in the county of Buckingham.

Statutory Instruments 1954 No. 206.

The Foot-and-Mouth Disease (Infected Areas) Special Order No. 9, 1954. (Made 24th February, 1954.)

1. Amends the Foot-and-Mouth Disease Infected Area around Caddington, Luton, Bedfordshire, by substituting the Petty Sessional Division of Dunstable for the Petty Sessional Division of Woburn in the Schedule to Special Order No. 7, 1954.

2. Contracts, as from 28th February, 1954, the Foot-and-Mouth Disease Infected Area around Bletchingley, Redhill, Surrey, declared by Special Order No. 5, 1954, to an area comprising the districts situate within approximately 5 miles of Bletchingley.

3. Releases such contracted Infected Area from restrictions on 7th March, 1954.
