"(i) With the consent (testified by his signing this Scheme) of the Reverend John William Joyce, as incumbent of the said benefice of Rothley the chapelry of Keyham, being a part of the benefice and parish of Rothley and comprising the whole of the civil parish of Keyham shall be severed from the bright parish of the benefice and parish and shall be permanently united to the benefice and parish of Houghton on the Hill and the united benefice shall be known as 'The United Benefice of Houghton on the Hill and Keyham'.

"(ii) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Sidney Freer Winckley if he is then incumbent of the said benefice of Houghton on the Hill shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice united benefice.

"(iii) Upon the union taking effect a capital sum sufficient to produce a permanent income of £50 per annum and now forming part of a larger sum beld by us, for the endowment of the said benefice of Rothley shall be severed or diverted from that benefice and shall be assigned and annexed to the united benefice of (Houghton on the Hill and Keyham.

"(iv) The united benefice shall be in the Archdeaconry of Leicester and the Rural Deanery of Goscote (First Deanery).

"2. Union of the chapelry of Wycombe and Chadwell and the benefice and parish of Scalford,

"(i) With the consent (testified as aforesaid) of "(i) With the consent (testified as aforesaid) of the Reverend John William Joyce as the incumbent of the said benefice of Rothley the chapelry of Wycombe and Chadwell being the detached part of the benefice and parish of Rothley which is totally enclosed by the present boundaries of the parishes of Goadby Marwood, Waltham on the Wolds and Scalford shall be severed from the remaining part of that benefice and parish and shall be permanently united to the benefice and parish of Scalford and the united benefice shall be known as 'The United Benefice of Scalford with Wycombe and Chadwells'. Chadwell '.

"(ii) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Robert Taylor Seivewright if he is then incumbent of the said benefice of Scalford shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"(iii) Upon the union taking effect a capital sum sufficient to produce a permanent income of £50 by us for the endowment of the said benefice of Rothley shall be severed or diverted from that benefice and shall be assigned and annexed to the united benefice of Scalford with Wycombe and Chadwell.

"(iv) The united benefice shall be in the Arch-deaconry of Leicester and the Rural Deanery of Framland (Third Deanery)."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Renefices Measures, 1923 to

suance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Thomas, Bishop of Carlisle (in witness whereof he has signed the Scheme) for effecting the unions of (1) the benefice of Castle Carrock with Cumrew and the benefice of Croglin (now part of the benefice of Kirkoswald and the benefice of Renwick (being the remaining part of the benefice of Croglin with Renwick) all of which benefices are situate in the diocese of Carlisle.

Union of the Benefices of Castle Carrock with Cumrew and Croglin.

"(1) The benefice of Castle Carrock with Cumrew and the benefice of Croglin, being part of the benefice of Croglin with Renwick, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Castle Carrock with Cumrew and Croglin' which united benefice shall be in the Archdeaconry of Carlisle and in the Rural Deanery of Brampton, but the parishes of the said benefices shall continue in all respects distinct.

"(II) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Arthur Mansfield Cook if he is then incumbent of the said benefice of Castle Carrock with Cumrew shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"(III) Upon the union taking effect the parsonage house at present belonging to the benefice of Castle Carrock with Cumrew shall be the house of residence of the incumbent of the united benefice.

"(IV) After the union has taken effect in every series of three successive turns of presentation to be made to the united benefice the patrons of the bene-fice of Castle Carrock with Cumrew shall have the
