the style of 'The United Benefice of Kirkoswald with Renwick,' but the parishes of the said benefices shall continue in all respects distinct.

"(II) The union shall take effect upon the day when any Order of Your Majesty in Council affirm-ing this Scheme is published in the London Gazette and the Reverend Canon Brian Desborough Lloyd Wilson if he is then incumbent of the benefice of Kirkoswald shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice united benefice.

"(IIII) Upon the union taking effect the parsonage house at present belonging to the benefice of Kirkoswald shall be the parsonage house of the united benefice.

"(IV) After the union has taken effect in every series of three successive turns of presentation to be made to the united benefice the patron of the benefice of Kirkoswald shall have the first and second turns and the alternate patron of the benefice of Croglin with Renwick who did not make the last presenta-tion to that benefice shall have the third turn.

"(V) Upon the union taking effect (a) the whole "(V) Upon the union taking effect (a) the whole of the endowments and property now belonging to the benefice of Croglin with Renwick with the ex-ception of the property mentioned in sub-paragraph (V) of paragraph 1 of this Scheme and (b) the whole of the endowments and property belonging to the benefice of Kirkoswald shall be annexed to and together form part of the united benefice."

And whereas the provisions of the Union of Benefices fices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisa-tion Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with :

And whereas the said Scheme has been approved at the Council held under the authority of the said Letters Patent:

Letters Patent: Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and Her Royal Highness The Princess Margaret, being authorised thereto by the said Letters Patent, have taken the said Scheme into consideration, and do hereby, by and with the advice of Her Majesty's Privy Council, on Her Majesty's behalf affirm the said Scheme and order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette Gazette.

WHEREAS 'Her Majesty, in pursuance of the Regency Acts, 1937 to 1953, was pleased, by Letters Patent dated the 20th day of November, 1953, to delegate to Her Majesty Queen Elizabeth The Queen Mother, Her Royal Highness The Princess Margaret, His Royal Highness The Princess Royal and the Earl of Harewood, or any two or more of them, as Coun-sellors of State, full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval of anything for which Her Majesty's approval in Council is required: And whereas the Church Commissioners have duly

And whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 31st day of March, 1954, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pur-suance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Eastleigh, and North Stoneham, both in the diocese of Winchester.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Alwyn, Bishop of Winchester, consents to the proposed arrangements (in testimony whereof he has signed this Scheme): "Now, therefore, we, the said Church Commis-sioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Eastleigh, and North Stoneham, shall be altered in the manner described in the Schedule be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

## " THE SCHEDULE.

"The territory to be annexed to the parish of Eastleigh :-

"(1) All that part (coloured pink on the map annexed hereto) of the parish of North Stoneham, which is bounded on the north by the parish of Saint Boniface, Chandlers Ford on the east by the parish of Eastleigh and on the remaining sides by an imaginary line commencing on the boundary which divides the parish of Eastleigh from the parish of North Stoneham at the junction of Passfield Avenue and Chestnut Avenue and con-tinuing thence westwards along the middle of Chestnut Avenue to a point in the middle of Middle Bridge and continuing thence northwards to and along the middle of Monks Brook to a point opposite the northwestern end of the wall or fence forming the northwestern boundary of close parish of Eastleigh and on the remaining sides by forming the northwestern boundary of close number 152 and continuing thence first westwards number 152 and continuing thence first westwards to and then southwestwards along the last men-tioned wall or fence and in the same line in con-tinuation thereof to a point in the middle of Magpie Lane and continuing thence northwards along the middle of the last mentioned Lane to a point opposite the eastern end of the walls or fences forming the southern boundary of closes num-bered 128 and 129 and continuing thence generally westwards to and along the last mentioned walls bered 128 and 129 and continuing thence generally westwards to and along the last mentioned walls or fences to the wall or fence which divides closes numbered 129 and 146 from close numbered 112 and continuing thence southwestwards along the last mentioned wall or fence and in the same line in continuation thereof to a point in the middle of Chestnut Avenue and continuing thence north-westwards along the middle of the last mentioned Avenue to its northern end opposite the middle of Bournemouth Road and continuing thence to and Bournemouth Road and continuing thence to and northwards along the middle of the last mentioned Bournemouth Road and continuing thence to and northwards along the middle of the last mentioned Road to a point opposite the middle of the south-eastern end of the footpath leading to Velmore Farm and continuing thence northwestwards to and along the middle of the last mentioned foot-path to the wall or fence which divides close number 739 from close number 8 and continuing thence northeastwards along the last mentioned wall or fence and in the same straight line in continuation thereof along the boundary of the Municipal Borough of Eastleigh to the boundary which divides the parish of North Stoneham from the parish of Saint Boniface, Chandlers Ford in the middle of Castle Lane. "(2) All that further part (coloured green on the map) of the parish of North Stoneham which is bounded upon the north and upon the northeast by the parish of Eastleigh and upon the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of North Stoneham from the parish of Eastleigh where it meets the eastern end of the walls or fences at the rear of the houses and premises on unbeast

meets the eastern end of the walks or fences at the rear of the houses and premises numbered 35 to 113 Monks Way and continuing thence west-wards along the last mentioned walks or fences and in the transition of the sector of wards along the last menutoned walls of rences and in the same straight line in continuation thereof for a distance of  $3\frac{1}{2}$  chains to a point opposite the southern end of the walls or fences at the rear of the houses and premises numbered 121 to 151 Monks Way and continuing thence north-wards to and along the last mentioned walls or fences and in the same line in continuation thereof along the wall or fence forming the western boun-dary of the house and premises numbered 211 Chestnut Avenue and thence in the same line to the boundary which divides the parish of North Stoneham from the parish of Eastleigh in the middle of Chestnut Avenue."
