**URBAN DISTRICT COUNCIL OF RAUNDS.**

*The Raunds Urban (Raunds No. 1) Diversion Order,  
1953.*

NOTICE is hereby given that on the 3rd day of May, 1954, the Minister of Housing and Local Government confirmed with modifications the above Order.

The effect of the Order is to divert the public right of way shown coloured brown on the map contained in the Order of the width of four feet leading from the north-western corner of the frontage fence of the house and premises No. 57 Midland Road at the point marked B on the said map and continuing in a south-easterly direction alongside the front fences of the houses and premises Nos. 57, 59 and 61 Midland Road for a distance of approximately 42 yards and thence in a north-easterly direction for a farther distance of approximately 15 yards to an opening in the hedge which forms the southern boundary of the highway known as Midland Road at the point marked A on the said map to a line shown coloured green on the map contained in the Order of the width of four feet leading from the north-western corner of the frontage fence of the house and premises No. 57 Midland Road at the point marked B on the said map and leading in continuation of the existing Berrister Field footpath in a north-easterly direction for a distance of approximately 15 yards to an existing opening in the hedge which forms the southern boundary of the highway known as Midland Road at the point marked C on the said map. The existing public right of way will be closed on and after the 18th day of May, 1954.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Council Offices, The Hall, Raunds, Wellingborough, and will be open for inspection free of charge between the hours of 9 a.m. and 5 p.m. on weekdays (9 a.m. to 12 noon on Saturdays).

The Order becomes operative as from the 11th day of May, 1954, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

**SADDLEWORTH URBAN DISTRICT COUNCIL.**

*Saddleworth Urban District Pennine Way Public  
Path Order, 1953.*

NOTICE is hereby given that on the 13th day of April, 1954, the Minister of Housing and Local Government confirmed with modifications, the above Order.

The effect of the Order is to create, from the 12th day of May, 1954, subject to certain limitations or conditions, a public right of way on foot over the land situate at Castleshaw Moor and Rocher Moss, within the Urban District of Saddleworth, for a distance of 3,000 yards between a point at National Grid Reference 004124 and a point at National Grid Reference 016100 and for a distance of 666 yards between a point at National Grid Reference 030089 and a point at National Grid Reference 034085, the width of the path being four feet.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister, has been deposited at the Council Offices, St. Chads, Uppermill, near Oldham, and will be open for inspection, free of charge, between the hours of 9 a.m. and 5 p.m. Mondays to Fridays and 9 a.m. to 12 noon Saturdays.

**AMENDED NOTICE.**
