## "SCHEDULE.

"(9) any payment to a curate or lay worker out of the benefice income.

"(11) any pension paid to a retired incumbent out of the benefice income,
"(12) any part of the benefice income diverted to the diocesan stipends fund pursuant to an Order under Section 12 of the Pastoral Reorganisation Measure, 1949."

WHEREAS Her Majesty, in pursuance of the Regency Acts, 1937 to 1953, was pleased, by Letters Patent dated the 20th day of November, 1953, to delegate to Her Majesty Queen Elizabeth The Queen Mother, Her Royal Highness The Princess Margaret, His Royal Highness The Princess Royal and the Earl of Harewood, or any two or more of them, as Counsellors of State, full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval of anything for

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a statutory district and eventual new parish to be taken out of the parishes of Biscot, Caddington, and Toddington in the diocese of Saint Albans.

## "SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a statutory district and eventual new

parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas we have not approved any consewithin the area as suitable to be the

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Michael, Bishop of Saint Albans (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

. Constitution.

(a) As from the date of the licence thereto of a Minister, the area defined in the sub-joined Schedule

Minister, the area defined in the sub-joined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The district (or parish) of Saint Luke, Leagrave'.

"2. Archdeaconry and Rural Deanery:
"The parish shall be in the Archdeaconry of Bedford and in the rural deanery of Luton.

## "THE SCHEDULE.

"The area comprising:

"The area comprising:—

"(a) All that part (coloured pink on the map) of the parish of Biscot which lies to the south west of an imaginary line commencing on the boundary which divides the parish of Biscot from the parish of All Saints, Luton at the point in the middle of the main line of the British Railways between London and Wellingborough where the last-mentioned boundary turns south westwards and continuing thence north westwards along the middle of the last-mentioned main line to the point at which it meets the boundary which divides the parish of Biscot from the parish of Sundon.

"(b) All that part (coloured green on the map) of the parish of Caddington which lies to the north of an imaginary line commencing at the point in the middle of the Luton and Dunstable Branch of the British Railways where the boundary which divides the parish of Caddington from the parish of All Saints, Luton turns north and continuing thence westwards along the middle of the said Branch of the British Railways to a point opposite the middle of Skimpot Road and continuing thence northwards to and along the middle of the last-mentioned road to the boundary which divides the parish of Caddington from the parish of Houghton Regis.

"(c) All that part (coloured yellow on the map) of the parish of Toddington which is enclosed within an imaginary line commencing at the point where the boundary which divides the parish of Toddington from the parishes of Sundon and Biscot crosses the boundary when divides the parish of Luton and continuing thence along the last-mentioned boundary first northwestwards and then generally southwest-
