TRUNK ROADS ACT, 1946.

SPECIAL ROADS ACT, 1949.

Ditton Cross Roads.

The Minister of Transport and Civil Aviation hereby gives notice that he proposes to make an Order under Section 14 of the Special Roads Act, 1949, the effect of which will be:—

(a) to provide for the re-alignment of the carriageway of that length of the road leading to Aylesford (B2011) at Ditton in the County of Kent which extends from its junction with the London—Folkestone—Dover Trunk Road in a north-easterly direction for a distance of approximately 60 yards;

(b) to provide for the construction by the Minister of a new road at Ditton from a point on the London—Folkestone—Dover Trunk Road approximately 45 yards east of its junction with the road leading to Aylesford (B2011) in a northerly direction for a distance of approximately 40 yards;

(c) that the Kent County Council will become the highway authority for the new road on the date on which notice is given by the Minister to the Council that the new road is opened for through traffic.

Copies of the draft Order and the relative plan may be inspected free of charge at all reasonable hours from 26th June, 1954, to 25th September, 1954, at the Ministry of Transport and Civil Aviation, 21-37, Hereford Road, London, W.2, and at the offices of the Kent County Council, County Hall, Maidstone.

Any person may within three months from 26th June, 1954, object to the making of the Order by notice to the Minister quoting reference HTR 34/19/05 and stating the grounds of objection.

SUPPLIES AND SERVICES (DEFENCE PURPOSES) ACT,
1951.
