The Importation of Carcases and Animal Products
Order, 1954. (Made 23rd June, 1954.)

This Order, which comes into operation on 3rd July, 1954, regulates the import into Great Britain of meat and animal products which may introduce animal diseases. The principal provision of the Order is that no person may land in Great Britain any carcases or animal products to which it applies except in accordance with a licence granted by the Minister of Agriculture and Fisheries. The Order, in its Schedules, also sets out (1) animal products to which the Order does not apply and which may, therefore, be imported unlicensed from all countries, (2) certain countries from which products to which the Order applies may be imported unlicensed, and (3) products which may be imported from specified countries, if certain safeguards are satisfied.
