The Sheep Scab (Amendment) (Revocation) Order, 1954 (Made 2nd July, 1954).

This Order, which came into operation on 5th July, 1954, revokes the Sheep Scab (Amendment) Order, 1951, which permitted sheep to be moved without a licence which would otherwise be necessary under the Sheep Scab Order, 1938, for movement from an area to which Part II of that Order applied (known as movement areas) to a slaughterhouse outside such an area provided the movement was under the supervision of an official of the Ministry of Food. Since 4th July the Ministry of Food have not supervised the movement of any sheep and permission to move without a licence is therefore withdrawn.
