*Milton, West Minster, Rochester and Gillingham Gas Works.*

## ROAD TRAFFIC ACT, 1930—SECTION 46 (1).

## ROAD AND RAIL TRAFFIC ACT, 1933—SECTION 29 (4).

NOTICE is hereby given that on the 16th day of July, 1954, the Minister of Transport and Civil Aviation confirmed the Wembley (Part of Bacon Lane, Kingsbury) (Roads Restriction) Order, 1954, made under section 46 (1) of the Road Traffic Act,

1930, and section 29 (4) of the Road and Rail Traffic Act, 1933.

The effect of the Order is to prohibit any person from driving or causing to be driven any vehicle other than a perambulator, invalid carriage propelled by hand, hand cart or pedal cycle pushed by hand on that length of Bacon Lane in the Borough of Wembley which lies between a point 160 yards west of its junction with Roe Green and a point 60 yards south of its junction with Goldsmith Lane.

## MABLETHORPE AND SUTTON URBAN DISTRICT COUNCIL.

*Mablethorpe and Sutton Urban District Council (Sutton Pleasure Gardens) Extinguishment Order, 1954.*

NOTICE is hereby given that on the 9th day of July, 1954, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order is to extinguish the public right-of-way over that part exceeding nine feet in width of the public right-of-way from High Street to the junction of Furlongs Road and York Road over that length of the said public right-of-way between the junction with High Street and a point 66 yards in a southerly direction. The path above mentioned will be closed from the 24th day of July, 1954.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Council Offices, Mablethorpe, and will be open for inspection free of charge between the hours of 10 a.m. and 5 p.m.

The Order becomes operative as from the 19th day of July, 1954, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

## MABLETHORPE AND SUTTON URBAN DISTRICT COUNCIL.

*Mablethorpe and Sutton Urban District Council (Sutton Pleasure Gardens) Diversion Order, 1954.*

NOTICE is hereby given that on the 9th day of July, 1954, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order is to divert the public right-of-way running from a point (B) 66 yards south of the junction of the said right-of-way with High Street (A) to the junction of the said right-of-way with Furlongs Road (C) to a line running from the said point (B) 66 yards south of the junction of the said right-of-way with High Street (A) in a south-westerly direction to a point in York Road (D). The path between points B and C above mentioned will be closed from the 24th day of July, 1954.
