#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952.

Pursuant to section 275 (5) of the Customs and Excise Act, 1952, and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending these Acts, certain goods, to wit 111 bales grey cotton piece goods imported at Liverpool on 20th April, 1954, marked 03-2233/2371 and 2273-2344 and valued at £6,812 12s. 5d. have been seized as liable to forfeiture upon the grounds that the said goods were imported contrary to the prohibition for the time being in force with respect thereto namely the Import of Goods (Control) Order, 1954, made under the Import, Export and Customs Powers (Defence) Act, 1939.

Whereby and by force of section 44 (b) of the Customs and Excise Act, 1952, and section 3 (1) and 3 (3) of the Import, Export and Customs Powers (Defence) Act, 1939, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the provisions of paragraph 3 of the 7th Schedule to the said Act, and in default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
