Nottingham, Holy Trinity with Saint Mark, both situate in the diocese of Southwell.

## "SCHEME

"1. Union of Benefices and Parishes. The benefice of Nottingham, Saint Matthew, and the benefice of Nottingham, Holy Trinity with Saint Mark, shall be permanently united together and form one benefice with cure of souls under the style of 'The united benefice of Nottingham, Holy Trinity' and the parishes of the said benefices shall also be united into one parish for ecclesiastical purposes.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Harry Holden if he is then incumbent of the benefice of Nottingham, Holy Trinity with Saint Mark, shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. Parish Church. The parish church of the parish of Holy Trinity with Saint Mark, Nottingham, shall be the parish church of the united parish.

"4. Registers. Upon the union taking effect the marriage registers in duplicate current at the church of Saint Matthew, Nottingham, shall be dealt with in accordance with Section 62 of the Marriage Act, 1949, and the register books of baptism and burials and other the records and muniments denosited in "1. Union of Benefices and Parishes. The benefice

1949, and the register books of baptism and burials and other the records and muniments deposited in the said church shall be transfered to the parish church of the united parish of Holy Trinity, Nottingham.

"5. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Nottingham, Holy Trinity with Saint Mark, shall be the house of residence of the incumbent of the united benefice, and the parsonage house belonging to the benefice of Nottingham, Saint Matthew, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient and the net proceeds of such sale or sales shall be held and applied by us towards sale of sales shall be lieft and applied by its towards the cost of the provision of a parsonage house for a new district (hereinafter called 'the said proposed new district') proposed to be formed wholly or partly out of the parish of Bestwood Park in the said diocese of Southwell.

"6. Taking down of church.

"(a) As soon as conveniently may be after the union has taken effect, the church of Saint Matthew, Nottingham, shall be taken down and the site thereof together with any ground annexed thereto and necessary for the use and enjoyment thereof shall be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measures.

"(b) The metricle of the said church of Soint

"(b) The materials of the said church of Saint Matthew, Nottingham, shall so far as the Bishop of Southwell may consider it practicable be used in the erection of a church for the said proposed new district and if not so used shall be sold by us.

"(c) The font, communion table and plate used for the purpose of the Holy Communion in the said church of Saint Matthew, Nottingham, shall not be sold but shall in accordance with the provisions of the said Union of Benefices Measures and as the Bishop of Southwell shall direct be transferred to the church of the said proposed new district or to some other church or churches within the diocese.

"(d) The bells, organ and other furniture and fittings of the said church of Saint Matthew, Nottingham, or such of them as the Bishop of Southwell shall select, shall be removed to the church of the said proposed new district, and any of such articles not so removed shall, as the said bishop shall direct, be transferred to any other church or chapel within the said diocese or shall be sold by us

be sold by us.

"(e) The net proceeds of any sales effected under the authority of this clause of this scheme, after payment of the expenses attendant thereon, and on the taking down of the church, and the removal of monuments (if any) and all other expenses incident to the church and the removal of monuments (if any) and all other expenses incident to the church and the church penses incidental to these matters, shall be applied by us towards the cost of the provision of a church for the said proposed new district.

"7. Provision for a curate or clerical or lay assistance. Upon the union taking effect a capital

sum sufficient to produce an annual income of £50 and being part of a larger capital sum held by us for the benefice of Nottingham, Saint Matthew, shall be appropriated as a fund towards the remuneration of a curate or other clerical or lay assistance em-ployed to assist the incumbent in performing the duties of the united benefice and the said annual income of £50 shall be paid by us to the diocesan board of finance of the said diocese as trustees to

apply the same accordingly.

"8. Diversion of Endowments. Upon the union taking effect all other the endowments held by us for the benefice of Nottingham, Saint Matthew, that is to say, a capital sum producing an annual income of £221 19s. 8d., shall be severed and diverted from that benefice and from the united benefice and shall be appropriated and held by us for and towards the

be appropriated and held by us for and towards the endowment of the said proposed new district: provided that pending the formation of the said proposed new district the income arising on the endowments so appropriated may, if the Bishop of Southwell shall so direct, be paid subject to such conditions as we may deem expedient towards the stipend of a curate serving the area intended to be comprised within the said proposed new district.

"9. Repair Fund. Upon the union taking effect the fund now held by the Incorporated Church Building Society for the repair, sustentation and insurance of the said church of Saint Matthew, Nottingham, shall be held by the said Society for the like purposes in connection with the parish church of the united parish and the income arising from time to time on the said fund shall be paid by the said Society to the incumbent and church-wardens for the time being of the united benefice wardens for the time being of the united benefice upon application to be applied by the said incumbent and churchwardens accordingly.

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly compiled with the comp

now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend John, Bishop of Derby (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Bretby and the benefice of Newton Solney both situate in the diocese of Derby.

## "SCHEME

"1. Union of Benefices. The benefice of Bretby and the benefice of Newton Solney shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Bretby with Newton Solney,' but the parishes of the said benefices shall continue in all respects

distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Gerald Thomas Josling if he is then incumbent of the said benefice of Bretby shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice.

"3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Bretby shall be the house of residence of the incumbent of the united benefice and the parsonage house belonging to the benefice of Newton
