"THE SCHEDULE

"The territory to be annexed to the parish of Saint John the Evangelist, Moor Allerton:—

"All that part (coloured pink on the map annexed hereto) of the parish of Meanwood which is bounded upon the northeast and the north by the parish of Saint John the Evangelist, Moor Allerton, upon the west by the parish of Adel, otherwise Addle, and upon the remaining side by an imaginary line commencing at a point on the boundary which divides the parish of Adel, otherwise Addle, from the parish of Meanwood in the middle of Scotland Mill Lane and extending thence southeastwards along the middle of the last mentioned Lane to its junction with Ring Road (Meanwood) and continuing thence southwards to and then generally eastwards along the middle of the last mentioned Road and along the middle of Ring Road (Moortown) to the boundary which divides the parish of Meanwood from the parish of Saint John the Evangelist, Moor Allerton."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 14th day of April, 1954, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Christopher, Bishop of Rochester (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Saint Mary, Chatham and the benefice of Saint John, Chatham both situate in the diocese of Rochester.

"SCHEME.

"1. *Union of Benefices.* The benefice of Saint Mary, Chatham and the benefice of Saint John, Chatham, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Mary and Saint John, Chatham,' but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Dennis McLean Oldaker if he is then incumbent of the said benefice of Saint John, Chatham, shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage House.*

"(a) Upon the union taking effect, the Bishop of the said diocese shall certify in writing which of the parsonage houses at present belonging to the benefices of Saint Mary, Chatham, and Saint John, Chatham, respectively shall be the house of residence of the incumbent of the united benefice and thereupon the parsonage house not so certified by the Bishop and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us, the said Church Commissioners, at

such time or times and in such manner in all respects as to us shall seem expedient.

"(b) The net proceeds of such sale or sales shall be applied by us as follows, that is to say:—(i) so much of the net proceeds as after consultation with the Bishop we shall deem sufficient shall be applied towards the cost of providing a house of residence for the incumbent of the new Ecclesiastical District of Saint Stephen, Chatham; and (ii) the balance (if any) of the said net proceeds shall be appropriated and held by us for the augmentation of the endowment of the united benefice.

"4. *Patronage.* The whole right of presentation to the united benefice shall be exercised by the patron of the benefice of Saint Mary, Chatham."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas an Appeal against the said Scheme has been made to Her Majesty in Council by Mrs. K. F. Forster, and such Appeal was referred to the Judicial Committee of the Privy Council on the 15th day of July, 1954:

And whereas the Lords of the said Committee have taken the said Appeal into consideration and, the Appellant having intimated the withdrawal of the said Appeal, have reported to Her Majesty in Council that the Appeal ought to be dismissed and the said Scheme affirmed:

And whereas Her Majesty was pleased, by and with the advice of Her Privy Council, by Order of the 30th day of July, 1954, to approve the said Report:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

"SCHEME

"1. *Union of Benefices.* The benefice of Matlock and the benefice of Tansley shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Matlock and Tansley', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Charles Henry Ferris if he is then incumbent of the said benefice of Matlock shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage House.*

"(a) Upon the union taking effect the parsonage house at present belonging to the benefice of Matlock shall be the house of residence of the incumbent of the united benefice.

"(b) Upon the issue, within the period of eighteen months following the taking effect of the union of benefices hereinbefore recommended and proposed, of a certificate by the bishop for the time being of the said diocese to the effect that the parsonage house at present belonging to the benefice of Tansley
