Just after midnight on 16th May, 1954, Corporal Ives, a member of the Station Police at Royal Air Force Station, Rostrup, discovered that two corporals who had gone out on a lake in a rowing boat during the evening had not returned. Fearing that some mishap had overtaken them, he went to the jetty in company with the Orderly Cor-poral and another Royal Air Force policeman and tried to attract the missing airmen's atten-tion. Shouts from the lake informed him that the boat was filling. A strong breeze was blow-ing and the water was very choppy. As the boat drew level with the end of the jetty one of the occupants stood up, whereupon the boat sank on a sandbank. The men started to wade towards the shore but, after going five to six yards, they were out of their depth. One of them could swim and struck out towards the shore but, realising that his companion was a non-swimmer, he went back for him. He was, however, unable to hold him up. Corporal Ives removed his outer cloth-ing and dived into the lake whilst the swimmer made for safety. Corporal Ives dived several times him up. Corporal Ives dived several times and at length found the unconscious man on the bottom. He brought him to the surface and, eventually, to the shore where artificial respira-tion was successfully performed. The part of the lake into which Corporal Ives jumped has been artificially deepened to a depth of about 12 feet. Weeds and reeds grow all round it and the bottom is strewn with all forms of debris. To jump into a dark, treacherous lake and search under water for an unconscious colleague was an under water for an unconscious colleague was an act of great bravery and showed complete dis-regard for personal safety. The man who was saved made a good recovery in hospital and was soon back to duty.
